



# Dr. Mehta's Hospitals performs rare and complicated surgery on 56-year-old

Chennai, Sept 10: Dr. Mehta's Hospitals, one of Chennai's leading hospitals has successfully performed a rare and complicated surgery on a 56-year-old female patient from Chennai with a swelling in the front of her neck. She has been suffering with this complaint for the past 18 months. When the swelling restricted her from swallowing solid food, she decided to come to Dr. Mehta's Hospital. When examined, an 8x7 cm lump in the anterior part of the neck that moved with swallowing was found. Tests were recommended and the results showed her blood investigations were within normal limits. A CT scan was also undertaken, and it confirmed the presence of a 94x83x61 mm dense

soft tissue mass in the thorax. CTVS Team was roped in and once again, a biopsy was performed to confirm the diagnosis. After necessary preoperative investigations, the patient was taken up for surgery, under General anaesthesia cervical thyroidectomy was done first and the neck lump along with thyroid gland was removed following which sternotomy using a power saw was performed and after intensive dissection the lump in the thorax was removed. Post operatively there was a good progress and hence the patient was discharged within a week. "The patient is recovering well and is expected to come in for a checkup shortly. If the swelling was not detected at this stage,

the lump would have increased resulting in a serious condition for the patient. We advise the public to constantly keep checking for any abnormal growth in the body or any difficulty they experience and attend to it immediately. Ignoring such symptoms can result in severe consequences, said, Dr. Amilthan, Consultant, General & Laparoscopic Surgery, Dr. Mehta's Hospitals. Malignant transformation in Ectopic Thyroid Tissue (ETT) is typically quite uncommon, however frequent monitoring will be advised if the patient chooses to forego surgical intervention in order to identify any early indications of thyroid malfunction or malignant change, said Dr Amilthan.

The Rotary Rainbow Project of Rotary International District 3232 and District 3201, an initiative to support the kin of suicide victims in Tamil Nadu, has been closely working with the families of suicide victims. They include the family of Kalimuthu, a constable of the Coimbatore armed city force, who took his own life in July, 2022. According to media reports, addiction



to online rummy was the reason for his extreme decision. The Rotary Rainbow project has been giving counseling to Late Kalimuthu's wife, Thillai and also supporting her children's education. The immediate family has said that the burden of the depth trap is the real reason for the suicide and not playing online games. It was reported in June,

2022, that Nagarajan, a painting contractor who lived with his family in Manali, took his own life, because he was addicted to online games. Rotary Rainbow Project is supporting the family of Nagaraja and mentoring them by offering moral as well as financial support. The victim's family has also said that Nagarajan had to take this extreme

step as he got caught in a debt trap. They also confirmed that his death had nothing to do with online games, as wrongly reported. Rtn PP Sridhar of Rotary Club of Chennai Infocity said, "The greatest gift of life is life itself. One of the most important ways to prevent suicide rates from growing is to recognize the real cause of these deaths and work towards finding a sustainable way of preventing them. Giving all suicide a singular misleading label will do a great disservice to humanity and to the victim's families."
